PROJECT PARTICIPANT DECLARATION

 - c) The Law of 11 July 2014 on the principles of implementing the programmes in the field of cohesion policy funded within the Financial Perspective 2014-2020 (OJ item 1146 as amended);
 - 2) With respect to the collection named Central IT System supporting the implementation of operational programmes:
 - a) Regulation (EU) No 1303/2013 of the European Parliament and the Council of 17 December 2013. laying down common provisions on the European Fund for Regional Development , European Social Fund, Cohesion Fund, European Agricultural Fund for Rural Development, European Maritime and Fisheries Fund and laying down common provisions on the European Fund for Regional Development , European Social Fund, Cohesion Fund, European Agricultural Fund for Rural Development, European Maritime and Fisheries Fund and repealing Council Regulation (EC) No 1083/2006,
